## NOTES FOR CANDIDATES FOR THE BOARD OF DIRECTORS

As stated in the Notice, nominations for the Board of Directors must be received by the Secretary's representative no later than 5 pm on Friday 23 February 2007.

The Club will immediately post a register of all nominees, and proposers, for the position of Director on the Club's notice board and website of the South Sydney District Rugby League Football Club ([www.souths.com.au](http://www.souths.com.au)) upon the collation of all nominations.

## PROXY VOTING

The relevant laws governing Proxy Voting are contained within the Corporations Law. The provision of proxy voting is mandatory for public companies, unless the company is a registered (licensed) club.

The legislation provides that for a proxy's appointment to be valid, the Member must forward the proxy's appointment to the company at least 48 hours before the meeting. Accordingly, to ensure the validity of a proxy vote, the proxy must be delivered to the Returning Officer (care of the Club) by 9.30 am on Friday 9 March 2007.

There are certain procedures for proxy voting that need to be adhered to strictly to ensure the validity of the proxy, including:

- The proxy form must be signed and dated by the member including name, address, and membership number;
- The proxy must be eligible to be a proxy;
- The member giving the proxy must be entitled to vote;
- Proof of identity of the proxy holder must be provided (a certified copy will suffice);
- Where the proxy has signed under a power of attorney, the power, or a certified copy thereof, must also be lodged;
- Proxy documentation may be received by post, hand, or facsimile at the company's registered office; and
- A separate voting paper will be issued and completed for each proxy received.

# Chairman's Report



It is a special privilege to write this Chairman's Report as part of the first Annual Report to members on the activities of Member Co in its initial year of operation.

Both the Extraordinary General Meeting of members on 19 March 2006 and the official handover ceremony on 7 June 2006 will long be remembered as landmark dates in the history of our Club. Through the efforts of many, the new ownership structure has brought to the Club private investment of the highest calibre which is underpinned by substantial member rights that will ensure that the key heritage components of the Rabbitohs remain in the hands of members for generations to come.

I am sure that any objective bystander would already agree that the overwhelming vote of members in favour of this new structure has already been vindicated. Put simply, our Club has gone through a period of massive change in the last 6 months in terms of its football operations and administration. But it hasn't stopped there. The Football Club has also taken great strides outside the football arena by successfully tendering for the Leagues Club's real estate, by fast tracking the Redfern Oval development with City of Sydney Council and by generally lifting the standing of our Club in the broader community.

For these initiatives, all Rabbitoh members and supporters should feel a debt of gratitude to Russell Crowe and Peter Holmes à Court. These are not mere private investors looking for a quick financial gain from a business enterprise. To the contrary, both Russell and Peter have amply demonstrated their love for this Club and, more to the point, their effectiveness in getting the job done. As I said on 19 March and 7 June 2006, this unique partnership between two committed business entrepreneurs and a devoted membership is a perfect blend of 'private' and 'public' that is unique to the NRL and I am confident that all the hard work of the last few years in seeing such a special arrangement become a reality will ultimately produce the results our Club and its loyal members so richly deserve.

As members are aware, the first five directors and members of Member Co were, by necessity, the initial subscribers to the Company's incorporation. Since 7 June 2006, we have seen members transfer their membership to Member Co in overwhelming numbers so that, at the time of writing, I am pleased to announce that over 86% of the Football Club's members have now become members of Member Co. Similarly, 93% of the Life Members of the Football Club (all but 4) have transferred their valued life membership to Member Co. Needless to say, this is an overwhelming endorsement by the membership of the new corporate structure under which our Club now operates.

With this Annual Report, you will find the first financial accounts for Member Co for the trading period 13 February to 31 October 2006. The financial accounts, I believe, augur well for the future of Member Co, and the Board is delighted with the financial arrangements between Member Co and the Football Club thus far. In this regard, members will note that the Football Club has waived the 5% administration charge and that, as at 31 October, it held an amount of \$252,820 on behalf of Member Co by way of membership fees received to that date in respect of the 2007 year.

Also included in this Annual Report is a snapshot of the Football Club's financial performance to 31 October 2006.

As you will see, the financial results of the Football Club underline the fact that the Football Club is now on a solid financial footing. They also confirm for members what most members already knew: that our Football Club could not have continued for much longer under its prior structure given that it enjoyed neither the active financial support of a Leagues Club, nor any significant form of private investment.

The Member Co constitution provides that members will elect five directors at the forthcoming Annual General Meeting on 11 March 2006. Of those five, the two with the highest vote scores will automatically go through

to the Football Club Board to represent the interests of Member Co.

To date, it has been a special privilege for Jim Hatfield and me to assume those two positions, especially through the critical transitional period. Having personally experienced at close hand the highs and lows of this great Club since my own involvement with the Rabbitohs that began in 1999, I can assure members that this has been a rewarding period to be involved with the Club as it embarks upon a new chapter in its proud history through this partnership.

In closing, may I thank my fellow Member Co directors Jim Hatfield, Nik Hatzistergos, Ray Martin and Ken Stewart who each worked very hard in the lead up to the EGM in March last year and have continued their commitment to the Rabbitohs since that time under the new arrangements. A special acknowledgement to Nick Greiner who has made an important contribution to the Football Club in his period in office, and to the establishment of Member Co. May I also extend the Board's thanks to Brandon Punter and Leonie Gibbons who have overseen the affairs of Member Co from an administrative point of view with all the care and diligence we are already accustomed to from them.

2007 promises to be a year that we can look forward to with some optimism. It should hopefully be a time when we can all start to reap some of the rewards for many years of perseverance and even occasional pain. As always, I regard it as a privilege to be involved in the affairs of this great Club and to have assisted in ensuring that it not only endures, but prospers, for generations to come.

## 4. PRINCIPAL ACTIVITIES

The Company was incorporated on 13 February 2006. These financial statements are the Company's first annual financial statements and are for the period commencing 13 February 2006 and ending on 31 October 2006.

The principal activities of the company during the course of the period were the administration and management of members' interests in the South Sydney District Rugby League Football Club Limited ("the Football Club"), which it acquired following the restructure of the Football Club as detailed in the South Sydney Rabbitohs Co-Operation and Subscription Deed.

There were no other significant changes in the nature of the activities of the Company during the period.

## 5. OPERATING AND FINANCIAL REVIEW

The operating profit for the period was \$317,430. This result was after deriving \$96,459 in membership subscription revenue from 7 June 2006, payment of grants to the South Sydney District Rugby League Football Club Limited ("the Football Club") of \$83,577, recognising a share of the trading losses of the Football Club of \$131,449 since acquisition and recognising a gain on the acquisition of the Company's investment in the Football Club of \$448,879.

## 6. MEMBERSHIP

The Company is a company limited by guarantee and without share capital.

The numbers of members as at 31 October 2006 were 6,862.

## 7. ENVIRONMENTAL REGULATION

The Company is subject to various environmental regulations under both Commonwealth and State Legislation.

The Board believes that the Company has adequate systems in place for the management of its environmental requirements and is not aware of any breach of those environmental requirements as they apply to the company.

## 8. DIVIDENDS

The Company is a company limited by guarantee and is prevented by its constitution from paying dividends.

## 9. EVENTS SUBSEQUENT TO REPORTING DATE

Subsequent to year end, the South Sydney District Rugby League Football Club Limited ("the Football Club") was the successful tenderer to purchase the freehold land and buildings of the South Sydney Leagues Club Limited under a tender undertaken by the Administrator of that company. This transaction will affect the value of the Company's investment in the Football Club in future years.

## 10. LIKELY DEVELOPMENTS

The directors do not anticipate any particular change in the operations of the company that will affect the results in subsequent years.

## 11. INDEMNIFICATION AND INSURANCE OF OFFICERS

The Company has paid insurance premiums of \$6,811 in respect of directors' and officers' liability and legal expenses' insurance contracts, for current and former directors and officers, including senior executives of the Company, directors, and the secretary of the company. The insurance premiums relate to:

- costs and expenses incurred by the relevant officers in defending proceedings, whether civil or criminal and whatever their outcome; and
- other liabilities that may arise from their position, with the exception of conduct involving a wilful breach of duty or improper use of information or position to gain a personal advantage.

The Company's profit for the period amounted to \$317,430.

Individual items that have significantly impacted the result include:

- payment of a grant to South Sydney District Rugby League Football Club Limited ("the football club") amounting to \$83,577;
- membership revenue of \$96,459;
- recognition of the share of losses of the football club post acquisition, amounting to \$131,449; and
- recognition of the share of the gain on acquisition of the investment in the football club, amounting to \$448,879.

### DISCUSSION AND ANALYSIS OF THE STATEMENT OF RECOGNISED INCOME AND EXPENSES

Total retained earnings increased by \$317,430 during the period ended 31 October 2006, representing the profit for the period.

### DISCUSSION AND ANALYSIS OF THE BALANCE SHEET

The company's net assets for the period amount to \$317,430. The company's total assets amounted to \$570,250 and total liabilities amounted to \$252,820.

Major movements during the period were as follows:

- trade and other receivables of \$252,820, representing amounts receivable from the football club;
- investment in associate amounting to \$317,430; and
- trade and other payables amounting to \$252,820, representing unearned membership income received.

### DISCUSSION AND ANALYSIS OF THE STATEMENT OF CASH FLOWS

There were no cashflows recognised in the statement for the period ended 31 October 2006, given the football club administers cash receipts and payments on behalf of the company.

The Beginning.....

South Sydney District Rugby League Football Club was formed at a public meeting held at Redfern Town Hall on 17 January 1908.

On March 5, 1908, the NSW Rugby League issued the Club its receipt No. 2 for their £ -1 - 1 - 0 affiliation fee.

The Club's first premiership match, also the first in the NSWRL competition, was played at Birchgrove Oval on Easter Monday, 20 April 1908. Souths defeated North Sydney 11-7. Winger Tommy Anderson scored Souths first try, with others added during the historic game by forwards Dick Green and Harold Butler, who also kicked a goal.

The Club was incorporated as a company limited by guarantee at a Special General Meeting on 13 June 1982.

The rebirth of the Rabbitohs began on 7 June, 2006 through a new partnership between Russell Crowe, Peter Holmes à Court and the 8000 Members of the Club. The voting Members of the Football Club voted by a 75.8% majority to convert the Club from a company limited by guarantee to a company limited by shares at an Extraordinary General Meeting held on 19 March 2006.
