Chairman's

Report

I write this report on the eve of our Football Club's historic return to a renovated and remodelled Redfern Oval, an event that eloquently demonstrates just how much progress we have all made together in recent years. No other club in the competition can boast a facility like Redfern Oval which now sets new standards across sport for the training of elite athletes. For this, we are deeply indebted to the Council of the City of Sydney, not only for the large capital investment it has made in the development, but also for recognising and helping to preserve a place of such deep significance for generations of Rabbitohs supporters and for the local community in general.

Of course, the re-development of Redfern Oval is only one part of the broader regeneration of the entire Chalmers Street precinct and I am delighted that the simultaneous remodelling of our Leagues Club building is well underway. Thanks to the skill and dedication of our partner in this venture, Trivest, we will have at our disposal during the course of 2009 a splendid new facility that will house a new and welcoming Leagues Club and offices for our Football Club. Not only will this at last deliver the "one Club" philosophy we promised to provide to Members, it will also epitomise that our Club's home is, and forever will be, in Redfern where it all began over a century ago.

In achieving such a milestone over repeated (and often ill-intentioned) calls over recent years for the Club's relocation, we are indebted to you, our Members, and to our sponsors. Foremost among the latter is the NAB which has not only set new standards in terms of sponsorship in our code, but has also joined with us and with Trivest as our funding partner for the Leagues Club re-development.

In terms of our squad, we are quietly confident that 2009 will deliver the results we had all

hoped for from 2008. With some key additions to our squad, with a more settled training regime at Redfern Oval and with our Head Coach Jason Taylor now ably supported by specialist coaching staff and a strong football administration team under John Lang, there is every reason to believe that 2009 will deliver on the promise we have shown in recent years. Of course, nothing is ever certain, but everything points to a substantially improved performance on the field in the forthcoming year.

In terms of financial performance, 2008 year was another year of growth in our revenues (by almost 6%). On the expenditure side, expected one-off outlays incurred as part of the Club's continued expansion produced the expected operating loss which has been largely funded by the continuing generosity of our investors, Russell Crowe and Peter Holmes à Court. Needless to say, the sheer scale of the changes we have implemented over the last two years could not have been contemplated without such generosity.

As Members will recall, the losses the Football Club has incurred as it goes through this period of growth can have no impact on Member Co's 25% stake and, more importantly, on its preference share through which it is the custodian of the core heritage values of our Club. Under the terms of our arrangement with our investors, Member Co is only obliged to recognise losses of the Football Club to the extent of its own net assets, and nothing more. In other words, Member Co can never have a deficiency in Member's funds and this ensures that it will continue to fulfil the important role it has been charged with for generations to come.

As Members know, 2008 also saw some changes to the Board of the Football Club which resulted, for the first time, in a Member Co nominee to the Board appointed to the

position of Chairman of the Football Club. This significant step was a demonstration of the confidence of our investors towards the Member Co representatives and the strong sense of common purpose that exists between us in our charter to make the Rabbitohs a leading force in the NRL again.

On the Member Co Board, it has been a pleasure to serve with Nik Hatzistergos, Jim Hatfield, Ray Martin and Ken Stewart, each of whom has done his utmost to contribute to the long term interests of our Club. This can be no better demonstrated than by the fact that Ken Stewart was recently appointed as the new CEO of the Leagues Club. Long gone are the days when the Leagues Club and the Football Club did not share a common purpose.

In closing, there is much to be excited about as we enter the 2009 playing season. With our training facility now firmly entrenched in Redfern, with a new Leagues Club and Football administration offices to be launched during the year within the same precinct, with our corporate and individual sponsor ranks led by NAB, Virgin Blue and De'Longhi exceeding all previous levels and, most importantly, with Members demonstrating their loyalty to the Club through record ticketed membership sales, one could not ask for more. For that, we thank you, the loyal Members of the Rabbitohs, who continue to defy the cynics who underestimate the inner strength and resilience our Club possesses through its membership.

The principal activities of the Company during the course of the year were the administration and management of members' interests in the South Sydney District Rugby League Football Club Limited ("the Football Club").

There were no other significant changes in the nature of the activities of the Company during the period.

5. OPERATING AND FINANCIAL REVIEW

The operating result for the year was nil (2007 profit: \$317,430). This result was after deriving \$317,323 (2007: \$274,856) in membership subscription revenue, awarding grants to the South Sydney District Rugby League Football Club Limited ("the Football Club") of \$84,661 (2007: \$111,010) and recognising a share of the trading losses of the Football Club of nil (2007: (\$317,430).

The Company operating loss of South Sydney District Rugby League Football Club Limited for the year was \$2,828,925 (2007: \$4,696,683) before taking in account exceptional items.

6. MEMBERSHIP

The Company is a company limited by guarantee and without share capital. The number of members as at 31 October 2008 was 9,973 (2007: 9.199).

7. ENVIRONMENTAL REGULATION

The Company is subject to various environmental regulations under both Commonwealth and State Legislation.

The Board believes that the Company has adequate systems in place for the management of its environmental requirements and is not

The Company's total revenue for 2008 increased by \$42,467 to \$317,323. Total operating expenses have increased by \$68,816 with the Company also awarding grants of \$84,661 and recognising a share of the losses of the Football Club amounting to nil.

Individual items that have significantly impacted the result include:

- Decrease in the payment of a grant to the Football Club by \$26,349 (23%);
- Increase in membership revenue by \$42,467 (15%), reflecting the full year of operations of the Company;
- The recognition of a share of the loss of the Football Club of nil compared with the recognition of a loss of \$317,430 in the prior year, given the value of the Company's investment in the Football Club reduced to nil in the prior year.

- Increase in trade and other payables by \$23,442 (16%), representing unearned membership income received.

THE BEGINNING.....

South Sydney District Rugby League Football Club was formed at a public meeting held at Redfern Town Hall on 17 January 1908.

On March 5, 1908, the NSW Rugby League issued the Club its receipt No. 2 for their £ -1 - 1 - 0 affiliation fee.

The Club's first premiership match, also the first in the NSWRL competition, was played at Birchgrove Oval on Easter Monday, 20 April 1908. Souths defeated North Sydney 11-7. Winger Tommy Anderson scored Souths first try, with others added during the historic game by forwards Dick Green and Harold Butler, who also kicked a goal.

The Club was incorporated as a company limited 1953: Won the first and reserve grade by guarantee at a Special General Meeting on 13 June 1982.

The rebirth of the Rabbitohs began on 7 June, 2006 through a new partnership between Russell Crowe, Peter Holmes à Court and the 8000 Members of the Club. The voting Members of the Football Club voted by a 75.8% majority to convert the Club from a company limited by guarantee to a company limited by shares at an Extraordinary General Meeting held on 19 March 2006.
