Chairman's Report

My report to Members last year concluded with a comment regarding our desire to reach 10,000 ticketed members for the 2010 season. As they have always done, our fantastic supporters responded to that call with traditional vigour and loyalty and we were able to exceed this lofty target before the commencement of the 2010 season.

This achievement should not be understated. A club that a decade ago had faced the prospect of extinction is now leading the race in terms of ticketed membership. That such a transformation could come about so quickly, particularly since private investment was introduced to our Club in 2006, is a remarkable reflection on the strength of our supporter base. Never one to rest on its laurels, the Club has lifted the bar even higher this year, such that we hope to reach ticketed membership in excess of 14,000 in 2011, a figure that will leave our Sydney competitors some considerable distance behind.

While private investment has undoubtedly underpinned much of the success of recent years, we must never forget that we are blessed with a *third* investor that stands shoulder to shoulder with Russell Crowe and Peter Holmes à Court. That investor is the loyal South Sydney Member who each year makes his or her investment into the Club and supports the

Club through all its highs and lows. While the scale of that investment may not be as large, it is no less significant and it remains the bedrock upon which our Club sits as a major player in Australia's supporting landscape.

In terms of financial performance, the 2010 year delivered very encouraging results for the Football Club. Once again, revenues rose considerably, by almost \$1 million, while expenditure increased by only \$600,000. This translated last year's operating loss of \$258,527 into an operating *profit* of \$60,644. This is an impressive turnaround and is in line with projections made to Members by the Board and Management regarding a return to profitability for the Football Club.

This result comes into even sharper focus when one considers that there is no other Sydney club in the NRL competition that returned a profit in the 2010 year. The fact that we did so *without* any financial assistance from a licensed club and *without* any further funding from our investors, speaks in volumes for the dedication of our staff and for the commitment of our Members and sponsors.

As we embark upon a new season that marks 40 years since our last premiership victory, we are delighted to welcome Star City and Kenwood as major sponsors. They join a

dedicated group of sponsors, from our top-tier majors like De'Longhi and V8 Supercars, to our host of mid-tier sponsors and our dedicated small business supporters, all of whom display unwavering commitment to our Club by aligning their businesses with the Rabbitoh brand.

Within Member Co, the corporate entity that represents Members' interests within the broader Football Club, I have again been delighted to serve with a dedicated Board. As Member revenues continue to grow each year, Member Co increases in importance as the custodian of the core values that represent the 'DNA' of our Club – its colours, its logo, its prized location in the heartland of Sydney and its enduring legacy as the code's oldest and most successful club.

Lets us all hope that 2011 brings the results that we have yearned for over many years. Without doubt, the time has come to start reaping some rewards for the commitment and dedication displayed by so many.

The directors present their report together with the financial report of South Sydney Members Rugby League Football Club Limited ('the Company') for the financial year ended 31 October 2010 and the auditor's report thereon.

1. DIRECTORS

4. PRINCIPAL ACTIVITIES

The principal activities of the Company during the course of the financial year were the administration and management of members' interests in the South Sydney District Rugby League Football Club Limited ("the Football Club").

There were no significant changes in the nature of the activities of the Company during the year.

5. OPERATING AND FINANCIAL REVIEW

The operating result for the year was nil (2009: nil). This result was after deriving \$448,000 (2009: \$358,591) in membership subscription revenue, awarding grants to the Football Club of \$182,256 (2009: \$110,875) and recognising a share of the trading profits of the Football Club of nil (2009: nil).

The operating profit before financing costs of the Football Club for the year was \$627,746 (2009: \$234,815) and the Football Club operating profit after financing costs was \$60,644 (2009: loss of \$258,527).

6. SHORT AND LONG TERM OBJECTIVES AND CURRENT STRATEGY

The Company's objectives and strategies are consistent with, and aligned to, the Football Club's annual budget and three year business plan (2011-2013). The objectives, both short and long term, of this business plan, are to achieve sustained on-field success, ensure financial viability, and be good corporate citizens through the positive actions of the Football Club's related party, Souths Cares PBI Limited.

7. PERFORMANCE MEASUREMENT

The Company's performance measurements are consistent with, and aligned to, the sensitivity analysis of key variables and targets established within the Football Club's annual budget and three year business plan. The actual performance of the Football Club's business will be measured monthly against these key indicators, and further, on an annual basis through a more rigorous review.

8. MEMBERSHIP

The Company is a company limited by guarantee and without share capital. The number of members as at 31 October 2010 was 14,080 (2009: 11,270).

9. LIABILITY OF MEMBERS ON WINDING-UP

Every Member of the Company undertakes to contribute to the assets of the Company, in the event of the same being wound up while the Member is a member or within one year after the Member ceases to be a member of the Company, for payment of the debts and liabilities of the Company contracted before the Member ceases to be a member of the Company and of the costs, charges and expenses of winding up and for adjustment of rights of the contributors among themselves, such amount as may be required, not exceeding \$4.00.

10. DIVIDENDS

The Company is a company limited by guarantee and is prevented by its constitution from paying dividends.

11. EVENTS SUBSEQUENT TO REPORTING DATE

There has not arisen in the interval between the end of the financial year and the date of this report any item, transaction or event of a material and unusual nature likely, in the opinion of the directors of the Company to affect significantly the operations of the Company, the results of those operations, or the state of affairs of the Company, in future financial years.

Financials Notes to the financial statements

1. REPORTING ENTITY

The Company is incorporated and domiciled in Australia as a Company limited by guarantee. In accordance with the Constitution of the Company, every member of the Company undertakes to contribute an amount limited to \$4 per member in the event of the winding up of the Company during the time that he or she is a member or within one year thereafter.

The principal activities of the Company during the course of the financial year were the administration and management of members' interests in the South Sydney District Rugby League Football Club Limited ("The Football Club").

2. BASIS OF PREPARATION

(a) Statement of compliance

The financial report is a general purpose financial report which has been prepared in accordance with Australian Accounting Standards (AASBs) (including Australian Interpretations) adopted by the Australian Accounting Standards Board (AASB) and the Corporations Act 2001. The financial report of the company does not comply with International Financial Reporting Standards (IFRS's) as the company has adopted the exemption allowed for not for profit organisations under AASB 101 "Presentation of Financial Statements".

The financial statements were approved by the Board of Directors on 18 January 2011.

(b) Basis of measurement

The financial statements have been prepared on the historical cost basis.

(c) Functional and presentation currency

The financial report is presented in Australian dollars, which is the Company's functional currency.

(d) Use of estimates and judgements

The preparation of financial statements requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised and in any future periods affected.

3. SIGNIFICANT ACCOUNTING POLICIES

(a) Financial instruments

(i) Non-derivative financial instruments
Non-derivative financial instruments comprise trade and other receivables, cash and cash equivalents and trade and other payables.

Non-derivative financial instruments are recognised initially at fair value plus, for instruments not at fair value through profit or loss, any directly attributable transaction costs, except as described below. Subsequent to initial recognition non-derivative financial instruments are measured as described below.

Cash and cash equivalents comprise of cash balances and call deposits. Other non-derivative financial instruments are measured at amortised cost using the effective interest method, less any impairment losses.

Trade and other payables are stated at amounts contracted with suppliers/other parties. Trade payables are non-interest bearing and are normally settled within 30 days.

(b) Investments in associates

Associates are those entities in which the company has significant influence, but not control, over the financial and operating policies. The financial statements includes the company's share of the total recognised gains and losses of associates on an equity accounted basis, from the date that significant influence commences until the date that significant influence ceases. When the company's share of losses exceeds its interest in an associate, the company's carrying amount is reduced to nil and recognition of further losses is discontinued except to the extent that the consolidated entity has incurred legal or constructive obligations or made payments on behalf of an associate.

(c) Impairment Financial assets

A financial asset is assessed at each reporting date to determine whether there is any objective evidence that it is impaired. A financial asset is considered to be impaired if objective evidence indicates that one or more events have had a negative effect on the estimated future cash flows of that asset.

An impairment loss in respect of a financial asset measured at amortised cost is calculated as the difference between its carrying amount, and the present value of the estimated future cash flows discounted at the original effective interest rate. An impairment loss in respect of an available-for-sale financial asset is calculated by reference to its fair value.

Individually significant financial assets are tested for impairment on an individual basis. The remaining financial assets are assessed collectively in groups that share similar credit risk characteristics.

All impairment losses are recognised through profit or loss. Any cumulative loss in respect of an available-for-sale financial asset recognised previously in equity is transferred to profit or loss. An impairment loss is reversed if the reversal can be related objectively to an event occurring after the impairment loss was recognised.

For financial assets measured at amortised cost and available-for-sale financial assets that are debt securities, the reversal is recognised in profit or loss. For available-for-sale financial assets that are equity securities, the reversal is recognised directly in equity.

(d) Revenue

Revenue from services rendered comprises revenue from member subscriptions and is recognised through profit or loss when the services are provided. No revenue is recognised if there are significant uncertainties regarding recovery of the consideration due, the costs incurred or to be incurred cannot be measured reliably, there is a risk of cancellation of membership or there is continuing management involvement with the goods.

(e) Income tax

The Company is exempt from income tax under Division 50 of the Income Tax Assessment Act (1997).

(f) Goods and services tax

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the taxation authority. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the taxation authority is included as a current asset or liability in the balance sheet.

(g) New standards and interpretations not yet adopted

The following standards, amendments to standards and interpretations have been identified as those which may impact the entity in the period of initial application. They are available for early adoption but have not been applied in preparing this financial report:

- AASB 9 *Financial Instruments* includes requirements for the classification and measurement of financial assets resulting from the first part of Phase 1 of the project to replace AASB 139 *Financial Instruments: Recognition and Measurement*. AASB 9 will become mandatory for the Company's 30 June 2014 financial statements. Retrospective application is generally required, although there are exceptions, particularly if the entity adopts the standard for the year ended 30 June 2012 or earlier. The Company has not yet determined the potential effect of the standard.

- AASB 124 *Related Party Disclosures* (revised December 2009) simplifies and clarifies the intended meaning of the definition of a related party and provides a partial exemption from the disclosure requirements for government-related entities. The amendments, which will become mandatory for Company's 30 June 2012 financial statements, are not expected to have any impact on the financial statements.

- AASB 2009-5 *Further amendments to Australian Accounting Standards arising from the Annual Improvements Process* affect various AASBs resulting in minor changes for presentation, disclosure, recognition and

measurement purposes. The amendments, which become mandatory for the Company's 30 June 2011 financial statements, are not expected to have a significant impact on the financial statements.

- AASB 1053 *Application of Tiers of Australian Accounting Standards Requirements* establishes a differential financial reporting framework, which consists of two tiers of reporting requirements for reporting entities preparing general purpose financial statements: Tier 1 Australian Accounting Standards (full AASB recognition, measurement and disclosure); and Tier 2 Australian Accounting Standards – Reduced Disclosure Requirements (full recognition and measurement but reduced disclosure). The amendments, which are mandatory for the entity's 31 October 2014 financial statements, only affect presentation aspects of the financial statements. There is no impact on the financial position or financial performance of the entity.

The Company holds an equity interest in SSDRLFC comprising 1,000,000 ordinary shares (25% interest) and 1 A class Preference Share. The Preference Share has the following rights:

- (a) Other than in respect of any of the matters set out in (b) below, the holder of the Preference Share has no voting rights at any meeting of Members except in respect of any resolution proposing to amend or otherwise adversely affect the rights attaching to the Preference Share.
- (b) At all times while the Company remains a public company limited by guarantee and owns the legal and beneficial interest in the Preference Share, SSDRLFC must not, without the consent of the Company as holder of the Preference Share:
- (i) enter into a merger, joint venture, amalgamation or any similar form of arrangement with any other rugby league club;
- (ii) make any decision to list the share capital of SSDRLFC or a derivative business of SSDRLFC on the official list of a stock exchange; or
- (iii) change the Football Team's:
- A) team colours from Cardinal Red and Myrtle Green (other than where the design incorporates colours other than Cardinal Red and Myrtle Green due to maker's marks or any minor modifications which are in line with other teams and trends);
- (B) name from "South Sydney District Rugby League Football Club" or "Rabbitohs";
- (C) rabbit logos (other than any minor modifications which are in line with other teams and trends);
- (D) home ground to a venue outside the South Sydney District (excluding ANZ Stadium formerly known as Telstra Stadium); or
- (E) team song ("Glory, Glory to South Sydney").
- (c) The Preference Share entitles the holder to appoint two representatives to serve as Directors.
- (d) The Preference Share has no right to receive dividends.
- (e) The Preference Share is not transferable.
- (f) The Preference Share must not be purchased pursuant to a selective buy back without the written consent of the holder of the Preference Share.
- (g) No more than one Preference Share may be issued.
- (h) The Preference Share entitles the holder to priority in repayment of the amount of \$1.00 paid up on the Preference Share in priority to all other Shares in SSDRLFC in the event of winding up of SSDRLFC, and thereafter, has no further right to participate in any further assets of SSDRLFC upon its winding up.

The Football Club administered all cash receipts and payments on behalf of the Company. Accordingly no independent cash flows have been recorded by the Company for the current period.

The excess derived for the year ended 31 October 2010 of \$182,256 (2009: \$110,875) was granted to the Football Club in accordance with the terms of the restructure contained in the South Sydney Rabbitohs Co-Operation and Subscription Deed.

At year end an amount of \$196,795 (2009: \$177,291) is receivable from the Football Club with respect to 2011 subscription monies received on the Company's behalf.

13. FINANCIAL INSTRUMENTS

Credit Risk

The carrying amount of trade receivables represents the maximum credit exposure. The maximum exposure to credit risk at reporting date for trade receivables was \$196,795 (2009: \$177,291).

The aging of the trade receivable due from the Football Club at the reporting date was all current. No impairment loss was incurred during the year and no impairment provision was necessary at the reporting date.

THE BEGINNING.....

South Sydney District Rugby League Football Club was formed at a public meeting held at Redfern Town Hall on 17 January 1908.

On March 5, 1908, the NSW Rugby League issued the Club its receipt No. 2 for their £ -1 - 1 - 0 affiliation fee.

The Club's first premiership match, also the first in the NSWRL competition, was played at Birchgrove Oval on Easter Monday, 20 April 1908. Souths defeated North Sydney 11-7. Winger Tommy Anderson scored Souths first try, with others added during the historic game by forwards Dick Green and Harold Butler, who also kicked a goal.
