## **CHAIRMAN'S REPORT**

It is my pleasure to present to Members the 7th Annual Report of Member Co for the year ended 31 October 2012.

In the pages that follow, Members have an opportunity to reflect upon the financial and on-field achievements of our Club. In on-field terms, it was undoubtedly the Club's best season since 1989. Of equal importance, it was also the strongest performance by our Club in financial terms for many decades, a fact which augurs well for the long-term sustainability of our Club as a frontrunner in the NRL competition.

This year, we have included a detailed report from our Chief Financial Officer, Joe Kelly, which includes graphic representations that demonstrate just how strongly our Club continues to perform in terms of its revenues, expenditure, earnings and profitability. Also included within our CFO's report is some explanation regarding the generous advances made to the Football Club by our investors, Russell Crowe and Peter Holmes à Court, between 2006 and 2008 and the reporting requirements that flow from those further injections of funding.

This last point underscores again the enormous benefits private investment has delivered to our Club since 2006 and the role it has played in elevating our Club to the position it now holds in the competition. I am not speaking here just about on-field performance; our Club's status across our Code is now much envied, and there is little doubt that the injection of private capital has helped to propel our Club to the position it now holds. Put simply, our Club now stands securely on its own two feet.

But pure funding is never enough. Without the expertise and diligence of our management team led by Shane Richardson and Joe Kelly, the funds invested would not have borne the fruit they have, and to them we must be grateful. In fact, I cannot recall a time when we have been blessed with a more diligent and dedicated administration team.

In on-field terms, all Members are deeply appreciative of the significant cultural change Michael Maguire and his football staff have brought to our football ranks. In a relatively short time, Michael has skilfully moulded our talented roster into a formidable unit, while at the same time bringing to our Club a refreshing sense of purpose in all our on-field activities.

It would be remiss of me not to conclude this report without thanking, on behalf of our Board of Directors, the 22,154 Members who signed up for the 2012 season. They remain the lifeblood of this great Club and to them we are indebted, above all others.

In closing, may I thank my fellow Directors for the care they have displayed during the past year. Like them, and like all Members, I look forward to the exciting season that lies ahead of us.

## **CHIEF FINANCIAL OFFICER'S REPORT**

It is my pleasure to bring to you the first CFO report to Members. Following an impressive on-field campaign, the financial results for the year ended 31 October 2012 for both Member Co. and the Football Club are very encouraging.

#### **Member Co**

The Member Co. financial results are described in detail in the Financial Statements. The grant back to the Club has increased from \$0.19m to \$0.21m, with Membership subscriptions increasing on relatively flat Member expenses compared to the previous year. The Statement of Financial Position, which reports the 2013 subscriptions purchased in advance, indicates a slight reduction on the previous year. However, as there was a three week delay in subscriptions going on sale for next season, the result ultimately reflects an encouraging initial sale period. This provides the Club with confidence of achieving its 25,000 Membership target in 2013. At the time of writing this report, total Membership sales were at 19,340 against 17,247 at the same date last year.

#### **Football Club**

I take this opportunity to provide the Members with a more detailed overview of the Club's Financial Statements. The Key Financial Indicators (see opposite page) provide a snapshot of the Club's improving financial performance over the past five years. A key highlight is that for four years now, the Club has reported Earnings before Interest, Tax, Depreciation and Amortisation (EBITDA) of at least break-even, with combined EBITDA profits over that four year period of \$1.7m.

The Club has increased its **revenues** by \$4.2m since 2008, and in the 2012 year, revenues were up 12% (or \$1.8m) on the previous year. The major movements comprised \$0.8m in NRL Funding and \$0.4m in Merchandise sales, with the latter being linked closely to our excellent on-field performance.

**Expenditure** rose by \$1.6m over the same period and is up 10% (or \$1.6m) on the previous year. As Members know, the Club is committed to investing available funds into its football program, and to this end, football related costs were up \$0.8m, with other direct cost of sales increasing by \$0.5m. A key measure for the Club is its gross profit margin, and this improved from 12% in 2008, to 29% in 2012. In an absolute sense, the gross profit has increased by \$3.6m over this period to a very impressive \$5.4m.

Other Charges reported in the accompanying graph are all non-cash related. Of special mention are the net financing costs and the 'derecognition' of related party loans (which are addressed below) and the Income Tax Benefit. This tax benefit has arisen in 2012 as a result of the probability that the Club will generate taxable profits, with tax that would have otherwise been payable on these profits, being offset by accumulated

tax losses. This indicates the confidence that the Board and Management have regarding the Club's future profitability, the accuracy of the budgeting process, and the Club's ability to deliver against these budget projections, which for 2013 are reported below.

The Club's Statement of Financial Position reports that our deficiency in working capital has improved by \$6m to (\$0.83m), and our net asset deficiency has improved by \$3.2m to (\$2.8m). Both of these improvements mainly relate to the new related party loan terms that were finalised in November 2011.

## Russell Crowe and Peter Holmes à Court's advances to the Football

In addition to their capital investment, both our investors have injected further funds totalling \$6.15m into the Football Club. These advances were provided during 2007 and 2008, when the Club underwent a rapid and much needed transformation, on the following preferential terms:

- they are entirely unsecured and of a 'limited recourse' nature, and as such, are only ever repayable out of Club profits, but only if the cashflow permits it;
- the interest rate is a very modest 1% above the 30 day Bank Bill Swap reference rate (BBSW). The BBSW is currently 3.12%, thus the interest rate on these loans is 4.12%; and
- interest has been waived until 31 October 2014, and then only a small amount is payable. Full interest (but only at the preferential rate) is payable from 31 October 2015.

The fact that interest charges at higher rates have been reported in the Statement of Comprehensive Income (although no interest is currently payable) has been a source of some limited misunderstanding. This is merely because of an accounting requirement (under Accounting Standards in Australia) that we must report a notional commercial (fair value) interest charge on loans between related parties, even if none is payable, or if it is payable at a lesser rate, as it is here.

#### Conclusions

In conclusion, from 2013, with the unwavering ongoing support of our Members and Corporate Partners, along with the improving NRL grant funding, the Club is strongly placed for its next growth phase. The budget for 2013 approved by our Board indicates for the first time a taxable profit in excess of \$1m, and our longer term business plans include strategies to further maximise the Club's strengthening financial performance.









#### 4. PRINCIPAL ACTIVITIES

The principal activities of the Company during the course of the financial year were the administration and management of Members' interests in the South Sydney District Rugby League Football Club Limited ("the Football Club").

There were no significant changes in the nature of the activities of the Company during the year.

#### 5. OPERATING AND FINANCIAL REVIEW

The operating result for the year was nil (2011: nil). This result was after deriving \$509,886 (2011: \$490,573) in Membership subscription revenue, awarding grants to the Football Club of \$204,598 (2011: \$192,768) and recognising a share of the trading profits/ (losses) of the Football Club of nil (2011: nil).

The operating result before financing costs and income tax of the Football Club for the year was a loss of \$406,558 (2011: loss of \$419,146) and the Football Club result after financing costs and income tax was a loss of \$346,090 (2011: loss of \$864,226), resulting in a positive movement of \$518,136 between financial years.

## 6. SHORT AND LONG TERM OBJECTIVES AND CURRENT STRATEGY

The Company's objectives and strategies are consistent with, and aligned to, the Football Club's annual budget and its business plan. The objectives, both short and long term, of this business plan, are to achieve sustained on-field success, ensure financial viability, and be good corporate citizens through the positive actions of the Football Club's related party. Souths Cares PBI Limited.

## 7. PERFORMANCE MEASUREMENT

The Company's performance measurements are consistent with, and aligned to, the sensitivity analysis of key variables and targets established within the Football Club's annual budget and its business plan. The actual performance of the Football Club's business will be measured monthly against these key indicators, and further, on an annual basis through a more rigorous review.

### 8. MEMBERSHIP

The Company is a company limited by guarantee and without share capital. The number of Members as at 31 October 2012 was 16,025 (2011: 15,418).





## 9. LIABILITY OF MEMBERS ON WINDING-UP

Every Member of the Company undertakes to contribute to the assets of the Company, in the event of the same being wound up while the Member is a Member or within one year after the Member ceases to be a Member of the Company, for payment of the debts and liabilities of the Company contracted before the Member ceases to be a Member of the Company and of the costs, charges and expenses of winding up and for adjustment of rights of the contributors among themselves, such amount as may be required, not exceeding \$4.

#### 10. DIVIDENDS

The Company is a company limited by guarantee and is prevented by its constitution from paying dividends.

## 11. EVENTS SUBSEQUENT TO REPORTING DATE

There has not arisen in the interval between the end of the financial year and the date of this report any item, transaction or event of a material and unusual nature likely, in the opinion of the directors of the Company to affect significantly the operations of the Company, the results of those operations, or the state of affairs of the Company, in future financial years.

## NOTES TO THE FINANCIAL STATEMENTS

#### 1. REPORTING ENTITY

The Company is incorporated and domiciled in Australia as a Company limited by guarantee. In accordance with the Constitution of the Company, every Member of the Company undertakes to contribute an amount limited to \$4 per Member in the event of the winding up of the Company during the time that he or she is a Member or within one year thereafter.

The principal activities of the Company during the course of the financial year were the administration and management of Members' interests in the South Sydney District Rugby League Football Club Limited ("The Football Club").

## 2. BASIS OF PREPARATION

(a) Statement of compliance
The financial report is a general purpose
financial report which has been prepared
in accordance with Australian Accounting
Standards (AASBs) adopted by the Australian
Accounting Standards Board (AASB) and the
Corporations Act 2001. The financial report of
the company does not comply with International
Financial Reporting Standards (IFRS's) as the
company has adopted the exemption allowed
for not for profit organisations under AASB 101
"Presentation of Financial Statements".

The financial statements were approved by the Board of Directors on 24 January 2013.

- (b) Basis of measurement
  The financial statements have been prepared on
  the historical cost basis.
- (c) Functional and presentation currency
  The financial report is presented in Australian
  dollars, which is the Company's functional
  currency.
- (d) Use of estimates and judgements
  The preparation of financial statements requires
  management to make judgements, estimates
  and assumptions that affect the application of
  accounting policies and the reported amounts of
  assets, liabilities, income and expenses. Actual
  results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the

period in which the estimate is revised and in any future periods affected.

## 3. SIGNIFICANT ACCOUNTING POLICIES

- (a) Financial instruments
- (i) Non-derivative financial instruments comprise trade and other receivables and trade and other payables.

Non-derivative financial instruments are recognised initially at fair value plus, for instruments not at fair value through profit or loss, any directly attributable transaction costs, except as described below. Subsequent to initial recognition non-derivative financial instruments are measured as described below.

Other non-derivative financial instruments are measured at amortised cost using the effective interest method, less any impairment losses.

Trade and other payables are stated at amounts contracted with suppliers/other parties. Trade payables are non-interest bearing and are normally settled within 30 days.

(b) Investments in associates Associates are those entities in which the company has significant influence, but not control, over the financial and operating policies. The financial statements includes the company's share of the total recognised gains and losses of associates on an equity accounted basis, from the date that significant influence commences until the date that significant influence ceases.

When the company's share of losses exceeds its interest in an associate, the company's carrying amount is reduced to nil and recognition of further losses is discontinued except to the extent that the company has incurred legal or constructive obligations or made payments on behalf of an associate.

## (c) Impairment Financial assets

A financial asset is assessed at each reporting date to determine whether there is any objective evidence that it is impaired. A financial asset is considered to be impaired if objective evidence indicates that one or more events have had a negative effect on the estimated future cash flows of that asset.

An impairment loss in respect of a financial asset measured at amortised cost is calculated as the difference between its carrying amount, and the present value of the estimated future

cash flows discounted at the original effective interest rate. An impairment loss in respect of an available-for-sale financial asset is calculated by reference to its fair value.

Individually significant financial assets are tested for impairment on an individual basis. The remaining financial assets are assessed collectively in groups that share similar credit risk characteristics.

All impairment losses are recognised through profit or loss. Any cumulative loss in respect of an available-for-sale financial asset recognised previously in equity is transferred to profit or loss

An impairment loss is reversed if the reversal can be related objectively to an event occurring after the impairment loss was recognised. For financial assets measured at amortised cost and available-for-sale financial assets that are debt securities, the reversal is recognised in profit or loss. For available-for-sale financial assets that are equity securities, the reversal is recognised directly in equity.

#### (d) Revenue

Revenue from services rendered comprises revenue from Member subscriptions and is recognised through profit or loss when the services are provided. No revenue is recognised if there are significant uncertainties regarding recovery of the consideration due, the costs incurred or to be incurred cannot be measured reliably, there is a risk of cancellation of Membership or there is continuing management involvement with the goods.

## (e) Income tax

The Company is exempt from income tax under Division 50 of the Income Tax Assessment Act (1997).

## 3. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

### (f) Goods and services tax

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the taxation authority. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the taxation

authority is included as a current asset or liability in the balance sheet.

(g) New standards and interpretations not yet adopted.

A number of new standards, amendments to standards and interpretations are effective for annual periods beginning after 1 November 2010, and have not been applied in preparing these consolidated financial statements. None of these is expected to have a significant effect on the financial statements of the Company, except for AASB 9 Financial Instruments, which becomes mandatory for the Company's 2016

consolidated financial statements and could change the classification and measurement of financial assets. The Company does not plan to adopt this standard early and the extent of the impact has not been determined.

AASB 9 Financial Instruments includes requirements for the classification and measurement of financial assets resulting from the first part of Phase 1 of the project to replace AASB 139 Financial Instruments: Recognition and Measurement. AASB 9 will become mandatory for the Company's 30 June 2016 financial statements. Retrospective

application is generally required, although there are exceptions, particularly if the entity adopts the standard for the year ended 30 June 2012 or earlier. The Company has not yet determined the potential effect of the standard.

#### 4. SEGMENT REPORTING

The Company predominately operates in one business segment being the administration and management of Members' interests in the South Sydney District Rugby League Football Club Limited in Australia.

The result before depreciation, amortisation, impairments and financing costs of SSDRLFC for the year was a profit of \$258,504 (2011: loss of \$17,411). The loss after financing costs and income tax was \$346,090 (2011: \$864,226).

The terms of the related party loan agreements were varied in November 2011. As a result of these variations, loan repayments now commence no earlier than 31 October 2015, and interest has been waived entirely until 31 October 2013 and is payable no earlier than 31 October 2014. In complying with Australian Accounting Standards, SSDRLFC is required to account for notional interest (not payable) resulting from the preferential terms of these related party loans and these financial results for SSDRLFC include notional interest amounting to \$459,839 (2011: \$217,544), as well as a loss of \$271,700 (2011: nil) on de-recognition of the previous loans.

The budget for 2013 indicates an operating profit before financing costs (interest charges and receipts), impairment charges and loan de-recognition losses of \$1,613,357. This represents an improvement at operating level before financing costs on 2012 of \$1,655,442.

The Football Club administered all cash receipts and payments on behalf of the Company. Accordingly no independent cash flows have been recorded by the Company for the current period.

The excess derived for the year ended 31 October 2012 of \$204,598 (2011: \$192,768) was granted to the Football Club in accordance with the terms of the restructure contained in the South Sydney Rabbitohs Co-Operation and Subscription Deed.

At the reporting date, an amount of \$180,186 (2011: \$183,303) is receivable from the Football Club with respect to 2013 subscription monies received on the Company's behalf.





## 13. FINANCIAL INSTRUMENTS

#### Credit Risk

The carrying amount of trade receivables represents the maximum credit exposure. The maximum exposure to credit risk at reporting date for trade receivables was \$180,186 (2011: \$183,303).

The aging of the trade receivable due from the Football Club at the reporting date was all current. No impairment loss was incurred during the year and no impairment provision was necessary at the reporting date.

## SOUTH SYDNEY DISTRICT RUGBY LEAGUE FOOTBALL CLUB LIMITED

The Beginning.....

South Sydney District Rugby League Football Club was formed at a public meeting held at Redfern Town Hall on 17 January 1908.

On March 5, 1908, the NSW Rugby League issued the Club its receipt No. 2 for their £ -1 - 1 - 0 affiliation fee.

The Club's first premiership match, also the first in the NSWRL competition, was played at Birchgrove Oval on Easter Monday, 20 April 1908. Souths defeated North Sydney 11-7. Winger Tommy Anderson scored Souths first try, with others added during the historic game by forwards Dick Green and Harold Butler, who also kicked a goal.

The Club was incorporated as a company limited by guarantee at a Special General Meeting on 13 June 1982.

The rebirth of the Rabbitohs began on 7 June, 2006 through a new partnership between Russell Crowe, Peter Holmes à Court and the 8000 Members of the Club. The voting Members of the Football Club voted by a 75.8% majority to convert the Club from a company limited by guarantee to a company limited by shares at an Extraordinary General Meeting held on 19 March 2006.
