CHAIRMAN'S REPORT

Building on the marvellous success of our historic 2014 premiership, the year 2015 was another year of prosperity for our great Club.

While the on-field results in finishing seventh and competing in only one semi-final left a few disappointed, there can be no doubt that the 2015 year was one of important progress and consolidation, particularly from a financial point of view.

As our Chief Financial Officer details in his report, our Membership rose to new record heights for our Code, with over 35,000 Members committing to our Club. This is an extraordinary number that raises the bar yet again and positions our Club firmly as the unchallenged benchmark in our game. What is equally gratifying is that our 2016 Membership numbers are already (at the time of writing) at almost 27,000, with still two months remaining before the first ball is kicked. Our loyal Members have risen to the challenge yet again.

The financial results of the Football Club are equally impressive. Despite not reaching the on-field heights of 2014, total revenues were only marginally lower at \$26.6m, while EBITDA and underlying profit were both impressive at \$1.8m and \$.96m respectively. These are results which set us well apart from any other Sydney sporting franchise. And they also demonstrate that Rugby League clubs can stand on their own feet once sound governance and astute management principles take root.

Perhaps the most significant event in the last 12 months was one I foreshadowed in last year's report. In October 2015, our two private investors graciously agreed to the complete discharge of their loan facilities on the most favourable terms for Members. This has had the effect of skyrocketing our net asset position to a record \$6.05m, the healthiest position the Rabbitohs have ever been in. I know I speak on behalf of all Members when I say that our appreciation goes out to our investors Russell Crowe and James Packer for helping to ensure that the Rabbitohs remain at the very forefront of our Code.

The challenge for us now is to continue to maintain and build upon recent years of on-field and off-field success. I am sure our Members, our administration team, our Head Coach, football staff and our wonderful roster of players will rise to that lofty challenge.

The future augurs well for the Rabbitohs.

FINANCE REPORT

It is my pleasure to present to Members the 2015 Finance report.

FOR THE YEAR ENDED 31 OCTOBER 2015

The financial results for the year ended 31 October 2015 for both Member Co. and the Football Club are a testament to the strong business practices and corporate governance that are now embedded within the organisation.

In Season 2015, Member Co. and the Football Club consolidated their strong positions and continued growth in key areas such as membership, social media KPIs, Sponsorship revenue and sponsor exposure while achieving a third consecutive profit and taking net assets to over \$6 million.

Member Co

The Member Co. financial results are described in detail in the Financial Statements.

The Statement of Profit & Loss and other comprehensive income reports a profit for the year of \$0.136m (2014: \$0.089m) representing its share of profits achieved by the Football Club in 2015. The grant back to the Club has increased to \$0.357m (2014: \$0.3m), membership subscriptions increasing to 23,995 (2014: 21,895), whilst the Football Clubs membership rose to a new record of 35,345 (2013: 30,563) - representing the highest Club membership in the NRL.


The Statement of Financial Position reports a positive net asset position of \$0.225m (2014: \$0.089m), with trade and other receivables and payables representing 2015 subscriptions purchased in advance totally \$0.336m (2014: \$0.335m). At the time of writing this report, total number of Football Club members for 2016 was at 26,710 and management are confident that the Club will exceed last year's record membership and set a new record.

Football Club

I take this opportunity to provide the Members with a more detailed overview of the Club's Financial Statements. A key financial metric for the Club is its Earnings before Interest, Tax, Depreciation and Amortisation (EBITDA), and over the past six years (see graph below), the Club has reported an EBITDA of at least break-even. This year, the Club reported an EBITDA result of \$1.8m which is an excellent financial result. While this result is down from the last two years which were fuelled by superior on field results, the result was better than budget expectations.

The Club's revenues totalled \$26.6m in 2015, which was a 3% decline on 2014. (see graph below). The Club continued its strong revenue performance in Sponsorship and membership, however merchandise revenue was down on the previous year which included the surge from the Premiership win. NRL grants includes the revenues from winning the Auckland Nines as well as the participation payment and prizemoney from the World Club Challenge.

REVENUE \$26.6 Million




Total **Expenditure and other charges** was even with the previous year. The Club is committed to investing available funds into its football program, and this year grew by \$.2m. Other direct cost of sales decreased by \$0.6m due to the lower turnover, particularly in merchandise described above, and other operating costs were up by \$0.4m

For the first time the Club will be required to pay tax on its 2015 results. Therefore to give a better comparison of performance over recent years the graph below shows profit (loss) before tax. The Club has delivered a profit before tax in 2015 of \$0.96m (2014: \$1.6m), which is a strong financial result and compares well with our historical results as illustrated in the graph below. The Club reported a profit after tax of \$0.544m.

The Club's Statement of Financial Position reports a positive net asset position at year end of \$6.05m (2014: \$0.35M) and a surplus in working capital of \$3.8m (2014: \$1.87m). The primary change here, apart from this years profitable trading, was the discharge of the loans to investors. This has dramatically strengthened the Club's balance sheet now and in to the future.

The cash reserves at year end were reported at \$4.36m, an increase from 2014 closing year end balance of \$4.25m after reducing the outstanding accounts payable balance by \$0.97m over the course of the year.

Conclusions

In conclusion, 2015 was another strong financial year for the Club. While it was not as successful as the past two years on or off the field, it was still an excellent year and continues to add to the strong financial foundations of the Club. The Club is projecting annual operating surpluses which are planned to be reinvested in to core competitive assets, with a particular focus of providing every possibility to succeed on-field.

4. PRINCIPAL ACTIVITIES

The principal activities of the Company during the course of the financial year were the administration and management of members' interests in the South Sydney District Rugby League Football Club Limited ("the Football Club").

There were no significant changes in the nature of the activities of the Company during the year.

5. OPERATING AND FINANCIAL REVIEW

The operating result of the Company for the year was a result of \$136,044 (2014: \$88,600). This result was after deriving \$763,477 (2014: \$696,659) in membership subscription revenue, awarding grants to the Football Club of \$357,017 (2014: \$300,278) and recognising a share of the trading profits/(losses) of the Football Club of \$136,044 (2014: \$88,600).

The operating result before income tax of the Football Club for the year was a profit of \$961,884 (2014: \$1,565,862). The Football Club result after income tax was a profit of \$544,175 (2014: \$1,990,354).

During the year, the Football Club's related party loans were repaid in full by the issue of a new class of preference share with limited rights to dividends from profits at the sole discretion of the Board of the Football Club and rights relating to the proceeds on winding-up.

6. SHORT AND LONG TERM OBJECTIVES AND CURRENT STRATEGY

The Company's objectives and strategies are consistent with, and aligned to, the Football Club's annual budget and its five year business plan (2013-17). The objectives, both short and long term, of this business plan, are to achieve sustained on-field success, ensure financial viability, and be good corporate citizens through the positive actions of the Football Club's related party, Souths Cares PBI Limited.

7. PERFORMANCE MEASUREMENT

The Company's performance measurements are consistent with, and aligned to, the sensitivity analysis of key variables and targets established within the Football Club's annual budget and its business plan. The actual performance of the Football Club's business are measured monthly against these key indicators, and further, on an annual basis through a more rigorous review.

8. MEMBERSHIP

The Company is a company limited by guarantee and without share capital. The number of members as at 31 October 2015 was 23,995 (2014: 21,895).



9. LIABILITY OF MEMBERS ON WINDING-UP

Every Member of the Company undertakes to contribute to the assets of the Company, in the event of the same being wound up while the Member is a member or within one year after the Member ceases to be a member of the Company, for payment of the debts and liabilities of the Company contracted before the Member ceases to be a member of the Company and of the costs, charges and expenses of winding up and for adjustment of rights of the contributors among themselves, such amount as may be required, not exceeding \$4.

10. DIVIDENDS

The Company is a company limited by guarantee and is prevented by its constitution from paying dividends.

11. EVENTS SUBSEQUENT TO REPORTING DATE

There has not arisen in the interval between the end of the financial year and the date of this report any item, transaction or event of a material and unusual nature likely, in the opinion of the directors of the Company to affect significantly the operations of the Company, the results of those operations, or the state of affairs of the Company, in future financial years.

NOTES TO THE FINANCIAL STATEMENTS

1. REPORTING ENTITY

The Company is incorporated and domiciled in Australia as a Company limited by guarantee. In accordance with the Constitution of the Company, every member of the Company undertakes to contribute an amount limited to \$4 per member in the event of the winding up of the Company during the time that he or she is a member or within one year thereafter.

FOR THE YEAR ENDED 31 OCTOBER 2015

The principal activities of the Company during the course of the financial year were the administration and management of members' interests in the South Sydney District Rugby League Football Club Limited ("The Football Club").

2. BASIS OF PREPARATION

(a) Statement of compliance

In the opinion of the directors, the Company is not publicly accountable. The financial statements are Tier 2 general purpose financial statements which have been prepared in accordance with Australian Accounting Standards – Reduced Disclosure Requirements adopted by the Australian Accounting Standards Board and the Corporations Act 2001. The financial report of the Company does not comply with International Financial Reporting Standards (IFRS's) due to the adoption of the Reduced Disclosure Requirements AASB's. This is the first accounting period for which financial statements have been prepared under the Reduced Disclosure Requirements framework. This has led to the removal of disclosures in relation to segment reporting, auditors' remuneration, reconciliation of cash flows from operating activities and financial instruments.

They were authorised for issue by the Board of Directors on 15 December 2015. Details of the Company's accounting policies, including changes during the year, are included in Note 3.

(b) Basis of measurement

The financial statements have been prepared on the historical cost basis.

(c) Functional and presentation currency

The financial report is presented in Australian dollars, which is the Company's functional currency.

(d) Use of estimates and judgements

In preparing these financial statements in conformity with Australian Accounting Standards – Reduced Disclosure Requirements, management has made judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised prospectively.

3. SIGNIFICANT ACCOUNTING POLICIES

(a) Financial instruments

(i) Non-derivative financial instruments

Non-derivative financial instruments comprise trade
and other receivables and trade and other payables.

Non-derivative financial instruments are recognised initially at fair value plus, for instruments not at fair value through profit or loss, any directly attributable transaction costs, except as described below. Subsequent to initial recognition non-derivative financial instruments are measured as described below. Other non-derivative financial instruments are measured at amortised cost using the effective interest method, less any impairment losses.

Trade and other payables are stated at amounts contracted with suppliers/other parties. Trade payables are non-interest bearing and are normally settled within 30 days.

(b) Investments in associates

Associates are those entities in which the company has significant influence, but not control, over the financial and operating policies. The financial statements includes the company's share of the total recognised gains and losses of associates on an equity accounted basis, from the date that significant influence commences until the date that significant influence ceases. When the company's share of losses exceeds its interest in an associate, the company's carrying amount is reduced to nil and recognition of further losses is discontinued except to the extent that the company has incurred legal or constructive obligations or made payments on behalf of an associate.

(c) Impairment

Financial assets

A financial asset is assessed at each reporting date to determine whether there is any objective evidence that it is impaired. A financial asset is considered to be impaired if objective evidence indicates that one or more events have had a negative effect on the estimated future cash flows of that asset.

An impairment loss in respect of a financial asset measured at amortised cost is calculated as the difference between its carrying amount, and the present value of the estimated future cash flows discounted at the original effective interest rate. An impairment loss in respect of an available-for-sale financial asset is calculated by reference to its fair value.

Individually significant financial assets are tested for impairment on an individual basis. The remaining financial assets are assessed collectively in companys that share similar credit risk characteristics.

All impairment losses are recognised through profit or loss. Any cumulative loss in respect of an available-for-sale financial asset recognised previously in equity is transferred to profit or loss.

An impairment loss is reversed if the reversal can be related objectively to an event occurring after the impairment loss was recognised. For financial assets measured at amortised cost, the reversal is recognised in profit or loss.

Equity-accounted investees

An impairment loss in respect of an equity-accounted investee is measured by comparing the recoverable amount of the investment with its carrying amount. An impairment loss is recognised in profit or loss, and is reversed if there has been a favourable change in the estimates used to determine the recoverable amount.

(d) Revenue

Revenue from services rendered comprises revenue from member subscriptions and is recognised through profit or loss when the services are provided. No revenue is recognised if there are significant uncertainties regarding recovery of the consideration due, the costs incurred or to be incurred cannot be measured reliably, there is a risk of cancellation of membership or there is continuing management involvement with the goods.

(e) Income tax

The Company is exempt from income tax under Division 50 of the Income Tax Assessment Act (1997).

(f) Goods and services tax

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the taxation authority. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the taxation authority is included as a current asset or liability in the balance sheet.

(g) New standards and interpretations not yet adopted

A number of new standards, amendments to standards and interpretations are effective for annual periods beginning after 1 January 2014, and have not been applied in preparing these financial statements. Those which may be relevant to the Company are set out below. The Company does not plan to adopt these standards early.

AASB 9 Financial Instruments (2014)

AASB 9 (2014), published in December 2014, replaces the existing guidance AASB 9 (2009), AASB 9 (2010) and AASB 139 Financial Instruments: Recognition and Measurement and is effective for annual reporting periods beginning on or after 1 January 2018, with early adoption permitted.

The key changes introduced in AASB 9 (2014) are:

- requirements for impairment of financial assets based on a three-stage 'expected loss' approach:
- ii. limited amendments to classification and measurement of financial assets to add a third measurement category for debt instruments. The new category

- of fair value through other comprehensive income is added to the existing categories for debt instruments, i.e. amortised cost and fair value through profit or loss; and
- iii. amendments to AASB 7 Financial Instruments: Disclosures that significantly expand the disclosures required in relation to credit risk

The Company is assessing the potential impact on its consolidated financial statements resulting from the application of AASB 9 (2014).

AASB 15 Revenue from Contracts with Customers

AASB 15 establishes a comprehensive framework for determining whether, how much and when revenue is recognised. It replaces existing revenue recognition guidance, AASB 111 Construction Contracts, AASB 118 Revenue and AASB 1004 Contributions. AASB 15 is effective from annual reporting periods beginning on or after 1 January 2017, with early adoption permitted.

The Beginning..

South Sydney District Rugby League Football Club was formed at a public meeting held at Redfern Town Hall on 17 January 1908.

On March 5, 1908, the NSW Rugby League issued the Club its receipt No. 2 for their £ -1 -1 -0 affiliation fee.

The Club's first premiership match, also the first in the NSWRL competition, was played at Birchgrove Oval on Easter Monday, 20 April 1908. Souths defeated North Sydney 11-7. Winger Tommy Anderson scored Souths first try, with others added during the historic game by forwards Dick Green and Harold Butler, who also kicked a goal.

The Club was incorporated as a company limited by guarantee at a Special General Meeting on 13 June 1982.

The rebirth of the Rabbitohs began on 7 June, 2006 through a new partnership between Russell Crowe, Peter Holmes à Court and the 8000 Members of the Club. The voting Members of the Football Club voted by a 75.8% majority to convert the Club from a company limited by guarantee to a company limited by shares at an Extraordinary General Meeting held on 19 March 2006.
