## **CHAIRMAN'S REPORT**

2016 was undoubtedly not the year we were all hoping for on the field. Nevertheless, while the season did not produce a semi-final appearance, it did culminate in a strong finish which augers well for the year ahead.

A less than pleasing season in football terms was matched by much consolidation and restructuring off the field. As Members know, the Football Club has for some years now experienced consistent profitability which, when coupled with the generosity of our investors, has fortified our balance sheet. This enabled us during the reporting year to re-invest heavily in our football activities through a re-structuring of our roster and of our football department. As our Chief Financial Officer reports, a total of \$2.7m has now been invested in these initiatives to revitalise all levels of our football programs and to position us well for a new cycle of on-field success.

Naturally, your Board is conscious that Members are unaccustomed to a loss of the magnitude we are reporting, but close inspection will reveal that it is, by and large, a product of the special football expenditure associated with these initiatives.

As ever, our Members have responded to these initiatives with gusto and, as at the date of writing, our membership for the 2017 season already exceeds 25,000. This is a stirring achievement which indicates that Members have taken to these initiatives with enthusiasm and share the Board's confidence that the dizzy heights we reached in 2014 will be re-claimed in the not too distant future.

Administratively, we were delighted to welcome Blake Solly to the Club as our new CEO. With a strong legal background and plentiful rugby league experience through his leadership of English Super League, Blake is the right person to lead this Club at this moment in its proud history. And, of course, we welcomed back Shane Richardson to devote himself to oversight of the football operations of the Club and he has already stamped that indelible 'Richo' mark on all that we do on the field.

On behalf of the Board of Directors of Member Co., I take this opportunity to thank Members for their loyalty and dedication. At the end of the day, the DNA of our Club is its membership base and that is something we never take for granted.

#### FINANCE REPORT

It is my pleasure to present to Members the 2016 Financial Report.

The financial results for the year ended 31 October 2016 for both Member Co. and the Football Club are reflective of a generally disappointing year on the field, coupled with the Board's commitment to invest in the football operations of the business to ensure we repeat the success of recent years.

The result was also impacted by the changes in NRL club funding announced in December 2015 and refined again in the more recent agreement reached with clubs in December 2016. The impact in the reporting year (and in 2017) was to remove \$750k of revenue, however the new funding package will provide for a far more beneficial arrangement over the life-cycle of the new broadcasting deal between 2018-2022.

#### Member Co

The Member Co. financial results are described in detail in the Financial Statements.

The Statement of Profit & Loss reports a loss for the year of \$0.225m (2015: profit \$0.136m) representing its share of the loss of the Football Club in 2016. As Members know, Member Co. is not required to contribute to any accumulated losses of the Football Club, hence Member Co.'s share of the loss is limited to the share of any profits previously recognised.

The grant back to the Football Club decreased to \$0.307m (2015: \$0.357m) in line with membership subscriptions decreasing to 22,453 (2015: 23,995), given that membership fell to 32,815 (2015: 35,345). While the Club's membership remains at the highest levels in the NRL, the 2016 result is a timely reminder of the importance of membership to the financial and operational health of the Club.

The Statement of Financial Position reports a neutral net asset position (2015: \$0.225m), with trade and other receivables and payables representing 2017 subscriptions purchased in advance totally \$0.295m (2015: \$0.336m). At the time of writing, the total number of Members for 2017 stood at 25,084 and management is confident that the Club will exceed last year's membership total.

#### Football Club

As is customary, I also take this opportunity to provide Members with a more detailed overview of the Football Club's Financial Statements.

The Football Club's revenues totalled \$24.7m in 2016, which represented a 7% decline on 2015 (see table below). The Club continued its strong performance in sponsorship, however merchandise, gate and membership revenues were down on the previous year. NRL grants also declined because of the reduction in funding referred to earlier, and also because 2015 included one-off revenues from the Auckland Nines and the participation payment and prizemoney from the World Club Challenge.

The Football Club increased its investment in its football programs by \$2.7m in 2016 (see table below). This included the costs related to our roster re-structure. Additional increases in football expenditure arose with the rise in the salary cap and staffing of the Football Department.

Other operating expenses fell by \$0.5m from reductions in variable costs and overheads to reduce the effects of lower revenue in commercial areas.

The Club's Statement of Financial Position reports a positive net asset position at year-end of \$3.315m (2015: \$6.05m) and a surplus in working capital of \$3.0m (2014: \$3.8m). The cash reserves at year end were reported at \$3.36m.

#### Conclusion

In conclusion, while 2016 was not the sort of year we have grown accustomed to, the Club is confident that the additional investment made in 2016 will deliver significant benefits in 2017 and beyond, both on and off the field.

#### 4. PRINCIPAL ACTIVITIES

The principal activities of the Company during the course of the financial year were the administration and management of members' interests in the South Sydney District Rugby League Football Club Limited ("the Football Club").

There were no significant changes in the nature of the activities of the Company during the year.

#### 5. OPERATING AND FINANCIAL REVIEW

The operating result of the Company for the year was a loss of \$224,644 (2015: \$136,044 profit). This result was after deriving \$714,414 (2015: \$763,477) in membership subscription revenue, awarding grants to the Football Club of \$306,784 (2015: \$357,017) and recognising a share of the trading profits/(losses) of the Football Club of (\$224,644) (2015: \$136,044 profit).

The operating result before income tax of the Football Club for the year was a loss of \$2,852,659 (2015: \$961,884 profit). The Football Club result after income tax was a loss of \$2,736,084 (2015: \$544,177 profit).

#### 6. SHORT AND LONG TERM OBJECTIVES AND CURRENT STRATEGY

The Company's objectives and strategies are consistent with, and aligned to, the Football Club's annual budget and its three year business plan (2017-19). The objectives, both short and long term, of this business plan, are to achieve sustained on-field success, ensure financial viability, and be good corporate citizens through the positive actions of the Football Club's related party, Souths Cares PBI Limited.

#### 7. PERFORMANCE MEASUREMENT

The Company's performance measurements are consistent with, and aligned to, the sensitivity analysis of key variables and targets established within the Football Club's annual budget and its business plan. The actual performance of the Football Club's business are measured monthly against these key indicators, and further, on an annual basis through a more rigorous review.

## 8. MEMBERSHIP

The Company is a company limited by guarantee and without share capital. The number of members as at 31 October 2016 was 22,453 (2015: 23,995).

# NOTES TO THE FINANCIAL STATEMENTS

#### 1. REPORTING ENTITY

The Company is incorporated and domiciled in Australia as a Company limited by guarantee. In accordance with the Constitution of the Company, every member of the Company undertakes to contribute an amount limited to \$4 per member in the event of the winding up of the Company during the time that he or she is a member or within one year thereafter.

The principal activities of the Company during the course of the financial year were the administration and management of members' interests in the South Sydney District Rugby League Football Club Limited ("The Football Club").

# 2. BASIS OF PREPARATION

#### (a) Statement of compliance

In the opinion of the directors, the Company is not publicly accountable. The financial statements are Tier 2 general purpose financial statements which have been prepared in accordance with Australian Accounting Standards - Reduced Disclosure Requirements adopted by the Australian Accounting Standards Board and the Corporations Act 2001. The financial report of the Company does not comply with International Financial Reporting Standards (IFRS's) due to the adoption of the Reduced Disclosure Requirements AASB's. This is the first accounting period for which financial statements have been prepared under the Reduced Disclosure Requirements framework. This has led to the removal of disclosures in relation to segment reporting, auditors' remuneration, reconciliation of cash flows from operating activities and financial instruments. They were authorised for issue by the Board of Directors on 15 December 2016. Details of the Company's accounting policies, including changes during the year, are included in Note 3.

## (b) Basis of measurement

The financial statements have been prepared on the historical cost basis.

## (c) Functional and presentation currency

The financial report is presented in Australian dollars, which is the Company's functional currency.

#### (d) Use of estimates and judgements

In preparing these financial statements in conformity with Australian Accounting Standards – Reduced Disclosure Requirements, management has made judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates. Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised prospectively.

## 3. SIGNIFICANT ACCOUNTING POLICIES

# (a) Financial instruments Non-derivative financial instruments

Non-derivative financial instruments comprise trade and other receivables and trade and other payables.

Non-derivative financial instruments are recognised initially at fair value plus, for instruments not at fair value through profit or loss, any directly attributable transaction costs, except as described below. Subsequent to initial recognition non-derivative financial instruments are measured as described below. Other non-derivative financial instruments are measured at amortised cost using the effective interest method, less any impairment losses.

Trade and other payables are stated at amounts contracted with suppliers/other parties. Trade payables are non-interest bearing and are normally settled within 30 days.

#### (b) Investments in associates

Associates are those entities in which the company has significant influence, but not control, over the financial and operating policies. The financial statements includes the company's share of the total recognised gains and losses of associates on an equity accounted basis, from the date that significant influence commences until the date that significant influence ceases. When the company's share of losses exceeds its interest in an associate, the company's carrying amount is reduced to nil and recognition of further losses is discontinued except to the extent that the company has incurred legal or constructive obligations or made payments on behalf of an associate.

## (c) Impairment

#### Financial assets

A financial asset is assessed at each reporting date to determine whether there is any objective evidence that it is impaired. A financial asset is considered to be impaired if objective evidence indicates that one or more events have had a negative effect on the estimated future cash flows of that asset.

An impairment loss in respect of a financial asset measured at amortised cost is calculated as the difference between its carrying amount, and the present value of the estimated future cash flows discounted at the original effective interest rate. An impairment loss in respect of an available-forsale financial asset is calculated by reference to its fair value.

Individually significant financial assets are tested for impairment on an individual basis. The remaining financial assets are assessed collectively in companys that share similar credit risk characteristics.

All impairment losses are recognised through profit or loss. Any cumulative loss in respect of an available

for-sale financial asset recognised previously in equity is transferred to profit or loss.

An impairment loss is reversed if the reversal can be related objectively to an event occurring after the impairment loss was recognised. For financial assets measured at amortised cost, the reversal is recognised in profit or loss.

#### Equity-accounted investees

An impairment loss in respect of an equity-accounted investee is measured by comparing the recoverable amount of the investment with its carrying amount. An impairment loss is recognised in profit or loss, and is reversed if there has been a favourable change in the estimates used to determine the recoverable amount.

## (d) Revenue

Revenue from services rendered comprises revenue from member subscriptions and is recognised through profit or loss when the services are provided. No revenue is recognised if there are significant uncertainties regarding recovery of the consideration due, the costs incurred or to be incurred cannot be measured reliably, there is a risk of cancellation of membership or there is continuing management involvement with the goods.

#### (e) Income tax

The Company is exempt from income tax under Division 50 of the Income Tax Assessment Act (1997).

#### (f) Goods and services tax

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the taxation authority. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Notes To The Financial Statements South Sydney Members Rugby League Football Club Limited

Receivables and payables are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the taxation authority is included as a current asset or liability in the balance sheet.

#### (g) New standards and interpretations not yet adopted

A number of new standards, amendments to standards and interpretations are effective for annual periods beginning after 1 January 2014, and have not been applied in preparing these financial statements. Those which may be relevant to the Company are set out below. The Company does not plan to adopt these standards early.

AASB 9 Financial Instruments (2014)

AASB 9 (2014), published in December 2014, replaces the existing guidance AASB 9 (2009), AASB 9 (2010) and AASB 139 Financial Instruments: Recognition and Measurement and is effective for annual reporting periods beginning on or after 1 January 2018, with early adoption permitted.

The key changes introduced in AASB 9 (2014) are:

- i. requirements for impairment of financial assets based on a three-stage 'expected loss' approach:
- ii. limited amendments to classification and measurement of financial assets to add a third measurement category for debt instruments. The new category of fair value through other comprehensive income is added to the existing categories for debt instruments, i.e. amortised cost and fair value through profit or loss; and
- iii. amendments to AASB 7 Financial Instruments: Disclosures that significantly expand the disclosures required in relation to credit risk.

The Company is assessing the potential impact on its consolidated financial statements resulting from the application of AASB 9 (2014).

#### **AASB 15 Revenue from Contracts with Customers**

AASB 15 establishes a comprehensive framework for determining whether, how much and when revenue is recognised. It replaces existing revenue recognition guidance, AASB 111 Construction Contracts, AASB 118 Revenue and AASB 1004 Contributions. AASB 15 is effective from annual reporting periods beginning on or after 1 January 2017, with early adoption permitted.

The Company is assessing the potential impact on its consolidated financial statements resulting from the application of AASB 15.

#### **AASB 16 Leases**

AASB 16 removes the classification of leases as either operating leases or finance leases – for the lessee - effectively treating all leases as finance leases. Short-term leases (less than 12 months) and leases of low-value assets (such as personal computers) are exempt from the lease accounting requirements. There are also changes in accounting over the life of the lease. In particular, companies will not recognise a front-loaded pattern of expenses for most leases, even when they pay constant rentals. Lessor accounting remains similar to current practice i.e. lessors continue to classify leases as finance and operating leases. AASB 16 is effective from annual reporting periods beginning on or after 1 January 2019, with early adoption permitted for entities that also adopt AASB 15. The Company is assessing the potential impact on its consolidated financial statements resulting from the application of AASB 16.

- (c) The Preference Share entitles the holder to appoint two representatives to serve as Directors of the SSDRLFC board.

- (g) No more than one Preference Share may be issued.
- (h) The Preference Share entitles the holder to priority in repayment of the amount of \$1.00 paid up on the Preference Share in priority to all other Shares in SSDRLFC in the event of winding up of SSDRLFC, and thereafter, has no further right to participate in any further assets of SSDRLFC upon its winding up.

#### SOUTH SYDNEY DISTRICT RUGBY LEAGUE FOOTBALL CLUB LIMITED

The Beginning...

South Sydney District Rugby League Football Club was formed at a public meeting held at Redfern Town Hall on 17 January 1908.

On March 5, 1908, the NSW Rugby League issued the Club its receipt No. 2 for their £ -1 - 1 - 0 affiliation fee.

The Club's first premiership match, also the first in the NSWRL competition, was played at Birchgrove Oval on Easter Monday, 20 April 1908. Souths defeated North Sydney 11-7. Winger Tommy Anderson scored Souths first try, with others added during the historic game by forwards Dick Green and Harold Butler, who also kicked a goal.

The Club was incorporated as a company limited by guarantee at a Special General Meeting on 13 June 1982.

The rebirth of the Rabbitohs began on 7 June, 2006 through a new partnership between Russell Crowe, Peter Holmes à Court and the 8000 Members of the Club. The voting Members of the Football Club voted by a 75.8% majority to convert the Club from a company limited by guarantee to a company limited by shares at an Extraordinary General Meeting held on 19 March 2006.


