# **CHAIRMAN'S REPORT**

If sporting clubs are to be measured solely by the performance of their teams on the field, then 2017 was not a year of high achievement for the Rabbitohs. Despite some stirring performances, and the signs of blossoming talent within our ranks, 2017, like the year before it, will go down in footballing terms as one of only modest achievement.

Nevertheless, sporting achievement in the elite codes is cyclical in nature and clubs must be ready to re-energise both their ranks and their strategies as the cycle of success ebbs and flows. To this end, in 2016, we embarked upon a process by which we invested heavily in our football activities through a complete restructuring of our roster and our football department. On this note, I take this opportunity to extend our special appreciation to our CEO, Blake Solly, who leads a very capable team of energetic and dedicated individuals across our Club's administration. #### FINANCE REPORT

It is my pleasure to present to Members the 2017 Financial Report.

The financial results for the year ended 31 October 2017 for both Member Co. and the Football Club are reflective of a year on the field that did not meet expectations. The Club and Michael Maguire mutually agreed to part ways and, as was the case in 2016, the NRL altered the nature of \$750k of 2017 grant revenue into an advance for future seasons. The impact in the reporting year was to remove \$750k of revenue in 2017, however the new funding package will provide a more beneficial arrangement over the life-cycle of the new broadcasting deal (between 2018-2022). The Football Club is budgeting to make a profit in 2018.

#### Member Co

The Member Co. financial results are described in detail in the Financial Statements.

The Statement of Profit & Loss reports a break even result for the year. As Member Co. is not required to contribute to any accumulated losses of the Football Club, there is no share of losses recognised in Member Co's accounts.

The grant back to the Football Club of \$0.315m (2016: \$0.307m) remained similar to last year despite Membership subscriptions decreasing to 20,461 (2015: 22,453), as Club Membership fell to 30,549 (2015: 32,815). Expenses were reduced slightly which enabled a similar grant.

The Statement of Financial Position reports a neutral net asset position, with trade and other receivables and payables representing 2018 subscriptions purchased in advance totally \$0.518m (2016: \$0.295m). The higher balance represents a much higher number of Members renewing before 31 October this year, which is a positive sign for total membership for 2018.

#### Football Club

As is customary, I also take this opportunity to provide Members with a more detailed overview of the Football Club's Financial Statements.

The Football Club's revenues totalled \$24.4m in 2017, which was similar to 2016 (see table below). The Club continued its strong performance in sponsorship, however merchandise, gate and Membership revenues were down on the previous year. NRL grants increased on the previous year, but were subject to the alteration in funding referred to earlier.

Overall expenses fell by \$1.5 million or 5.5% on the previous year. Both years included some significant one off costs in the Football Department. There was an emphasis on cost reduction this year, as commercial revenues remained under pressure. All areas of the business reduced costs, and this will continue into the 2018 season with the exception of the material increase in the NRL Salary Cap.

A cap on football department spending has been introduced by NRL for the 2018 season and beyond, which the Club is comfortably under. This cap will help contain football expenses across the industry.

# \$27.0 Million



The Club's Statement of Financial Position reports a positive net asset position at year-end of \$2.230m (2015: \$3.315m) and a surplus in working capital of \$2.0m (2014: \$3.0m). The cash reserves at year end were reported at \$4.45m.

#### Conclusio

The 2017 season did not meet our expectations on or off the field, however there was an improvement in the club's financial performance on the year before. As we head in to 2018 with a new NRL funding deal locked in for five years, we will return to profitability. We have continued to invest in the Football Department and firmly believe this will pay dividends on the field next season and into the future.

#### 4. PRINCIPAL ACTIVITIES

The principal activities of the Company during the course of the financial year were the administration and management of members' interests in the South Sydney District Rugby League Football Club Limited ("the Football Club").

There were no significant changes in the nature of the activities of the Company during the year.

#### 5. OPERATING AND FINANCIAL REVIEW

The operating result of the Company for the year was a profit of \$nil (2016: \$224,644 loss). This result was after deriving \$651,032 (2016: \$714,414) in membership subscription revenue, awarding grants to the Football Club of \$314,768 (2016: \$306,784) and recognising a share of the trading profits/(losses) of the Football Club of \$nil (2016: \$224,644 loss).

The operating result before income tax of the Football Club for the year was a loss of \$1,699,627 (2016: \$2,852,659 loss). The Football Club result after income tax was a loss of \$1,082,353 (2016: \$2,736,084 loss).

#### 6. SHORT AND LONG TERM OBJECTIVES AND CURRENT STRATEGY

The Company's objectives and strategies are consistent with, and aligned to, the Football Club's annual budget and its three year business plan (2017-19). The objectives, both short and long term, of this business plan, are to achieve sustained on-field success, ensure financial viability, and be good corporate citizens through the positive actions of the Football Club's related party, Souths Cares PBI Limited.

#### 7. PERFORMANCE MEASUREMENT

The Company's performance measurements are consistent with, and aligned to, the sensitivity analysis of key variables and targets established within the Football Club's annual budget and its business plan. The actual performance of the Football Club's business are measured monthly against these key indicators, and further, on an annual basis through a more rigorous review.

#### 8. MEMBERSHIP

The Company is a company limited by guarantee and without share capital. The number of members as at 31 October 2017 was 20,461 (2016: 22,453).

#### 9. LIABILITY OF MEMBERS ON WINDING-UP

Every Member of the Company undertakes to contribute to the assets of the Company, in the event of the same being wound up while the Member is a member or within one year after the Member ceases to be a member of the Company, for payment of the debts and liabilities of the Company contracted before the Member ceases to be a member of the Company and of the costs, charges and expenses of winding up and for adjustment of rights of the contributors among themselves, such amount as may be required, not exceeding \$4.

The Company is a company limited by guarantee and is prevented by its constitution from paying dividends.

# NOTES TO THE FINANCIAL STATEMENTS

#### 1. REPORTING ENTITY

The Company is incorporated and domiciled in Australia as a Company limited by guarantee. In accordance with the Constitution of the Company, every member of the Company undertakes to contribute an amount limited to \$4 per member in the event of the winding up of the Company during the time that he or she is a member or within one year thereafter.

The principal activities of the Company during the course of the financial year were the administration and management of members' interests in the South Sydney District Rugby League Football Club Limited ("The Football Club").

# 2. BASIS OF PREPARATION

#### (a) Statement of compliance

In the opinion of the directors, the Company is not publicly accountable. The financial statements are Tier 2 general purpose financial statements which have been prepared in accordance with Australian Accounting Standards - Reduced Disclosure Requirements adopted by the Australian Accounting Standards Board and the Corporations Act 2001. The financial report of the Company does not comply with International Financial Reporting Standards (IFRS's) due to the adoption of the Reduced Disclosure Requirements AASB's. This is the first accounting period for which financial statements have been prepared under the Reduced Disclosure Requirements framework. This has led to the removal of disclosures in relation to segment reporting, auditors' remuneration, reconciliation of cash flows from operating activities and financial instruments. They were authorised for issue by the Board of Directors on 14 December 2017. Details of the Company's accounting policies, including changes during the year, are included in Note 3.

# (b) Basis of measurement

The financial statements have been prepared on the historical cost basis.

# (c) Functional and presentation currency

The financial report is presented in Australian dollars, which is the Company's functional currency.

#### (d) Use of estimates and judgements

In preparing these financial statements in conformity with Australian Accounting Standards – Reduced Disclosure Requirements, management has made judgements, estimates

and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates. Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised prospectively.

## 3. SIGNIFICANT ACCOUNTING POLICIES

#### (a) Financial instruments Non-derivative financial instruments

Non-derivative financial instruments comprise trade and other receivables and trade and other payables.

Non-derivative financial instruments are recognised initially at fair value plus, for instruments not at fair value through profit or loss, any directly attributable transaction costs, except as described below. Subsequent to initial recognition non-derivative financial instruments are measured as described below. Other non-derivative financial instruments are measured at amortised cost using the effective interest method, less any impairment losses. Trade and other payables are stated at amounts contracted with suppliers/other parties. Trade payables are non-interest bearing and are normally settled within 30 days.

#### (b) Investments in associates

Associates are those entities in which the company has significant influence, but not control, over the financial and operating policies. The financial statements includes the company's share of the total recognised gains and losses of associates on an equity accounted basis, from the date that significant influence commences until the date that significant influence ceases. When the company's share of losses exceeds its interest in an associate, the company's carrying amount is reduced to nil and recognition of further losses is discontinued except to the extent that the company has incurred legal or constructive obligations or made payments on behalf of an associate.

#### (c) Impairment

# Financial assets

A financial asset is assessed at each reporting date to determine whether there is any objective evidence that it is impaired. A financial asset is considered to be impaired if objective evidence indicates that one or more events have had a negative effect on the estimated future cash flows of that asset.

An impairment loss in respect of a financial asset measured at amortised cost is calculated as the

difference between its carrying amount, and the present value of the estimated future cash flows discounted at the original effective interest rate. An impairment loss in respect of an available-forsale financial asset is calculated by reference to its fair value.

Individually significant financial assets are tested for impairment on an individual basis. The remaining financial assets are assessed collectively in companys that share similar credit risk characteristics.

All impairment losses are recognised through profit or loss. Any cumulative loss in respect of an available

for-sale financial asset recognised previously in equity is transferred to profit or loss.

An impairment loss is reversed if the reversal can be related objectively to an event occurring after the impairment loss was recognised. For financial assets measured at amortised cost, the reversal is recognised in profit or loss.

#### **Equity-accounted investees**

An impairment loss in respect of an equityaccounted investee is measured by comparing the recoverable amount of the investment with its carrying amount. An impairment loss is recognised in profit or loss, and is reversed if there has been a favourable change in the estimates used to determine the recoverable amount.

#### (d) Revenue

Revenue from services rendered comprises revenue from member subscriptions and is recognised through profit or loss when the services are provided. No revenue is recognised if there are significant uncertainties regarding recovery of the consideration due, the costs incurred or to be incurred cannot be measured reliably, there is a risk of cancellation of membership or there is continuing management involvement with the goods.

#### (e) Income tax

The Company is exempt from income tax under Division 50 of the Income Tax Assessment Act (1997).

# $(f) \ Goods \ and \ services \ tax$

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the taxation authority. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the

taxation authority is included as a current asset or liability in the balance sheet

#### (g) New standards and interpretations not yet adopted

A number of new standards, amendments to standards and interpretations are effective for annual periods beginning after 1 January 2014, and have not been applied in preparing these financial statements. Those which may be relevant to the Company are set out below. The Company does not plan to adopt these standards early.

#### AASB 9 Financial Instruments (2014)

AASB 9 (2014), published in December 2014, replaces the existing guidance AASB 9 (2009), AASB 9 (2010) and AASB 139 Financial Instruments: Recognition and Measurement and is effective for annual reporting periods beginning on or after 1 January 2018, with early adoption permitted.

The key changes introduced in AASB 9 (2014) are:

- i. requirements for impairment of financial assets based on a three-stage 'expected loss' approach:
- ii. limited amendments to classification and measurement of financial assets to add a third measurement category for debt instruments. The new category of fair value through other comprehensive income is added to the existing categories for debt instruments, i.e. amortised cost and fair value through profit or loss; and
- iii. amendments to AASB 7 Financial Instruments: Disclosures that significantly expand the disclosures required in relation to credit risk.

The Company is assessing the potential impact on its consolidated financial statements resulting from the application of AASB 9 (2014).

#### AASB 15 Revenue from Contracts with Customers

AASB 15 establishes a comprehensive framework for determining whether, how much and when revenue is recognised. It replaces existing revenue recognition guidance, AASB 111 Construction Contracts, AASB 118 Revenue and AASB 1004 Contributions. AASB 15 is effective from annual reporting periods beginning on or after 1 January 2017, with early adoption permitted.

The Company is assessing the potential impact on its financial statements resulting from the application of AASB 15.

#### AASB 16 Leases

AASB 16 removes the classification of leases as either operating leases or finance leases – for the lessee - effectively treating all leases as finance leases. Short-term leases (less than 12 months) and leases of low-value assets (such as personal computers) are exempt from the lease accounting requirements. There are also changes in accounting over the life of the lease. In particular, companies will not recognise a front-loaded pattern of expenses for most leases, even when they pay constant rentals. Lessor accounting remains similar to current practice i.e. lessors continue to classify leases as finance and operating leases. AASB 16 is effective from annual reporting periods beginning on or after 1 January 2019, with early adoption permitted for entities that also adopt AASB 15. The Company is assessing the potential impact on its financial statements resulting from the application of AASB 16.

- (a) Other than in respect of any of the matters set out in (b) below, the holder of the Preference Share has no voting rights at any meeting of Members except in respect of any resolution proposing to amend or otherwise adversely affect the rights attaching to the Preference Share.
- (b) At all times while the Company remains a public company limited by guarantee and owns the legal and beneficial interest in the Preference Share, SSDRLFC must not, without the consent of the Company as holder of the Preference Share:
- (i) enter into a merger, joint venture, amalgamation or any similar form of arrangement with any other rugby league club;

  - (B) name from "South Sydney District Rugby League Football Club" or "Rabbitohs";
  - (C) rabbit logos (other than any minor modifications which are in line with other teams and trends);
  - (D) home ground to a venue outside the South Sydney District (excluding ANZ Stadium, formerly known as Telstra Stadium);
  - (E) team song ("Glory, Glory to South Sydney").

- (c) The Preference Share entitles the holder to appoint two representatives to serve as Directors of the SSDRLFC board.
- (d) The Preference Share has no right to receive dividends.
- (e) The Preference Share is not transferable.
- (f) The Preference Share must not be purchased pursuant to a selective buy back without the written consent of the holder of the Preference Share.
- (g) No more than one Preference Share may be issued.
- (h) The Preference Share entitles the holder to priority in repayment of the amount of \$1.00 paid up on the Preference Share in priority to all other Shares in SSDRLFC in the event of winding up of SSDRLFC, and thereafter, has no further right to participate in any further assets of SSDRLFC upon its winding up.

Based on the above rights, the Company is deemed to have significant influence over SSDRLFC.

No charge was levied with respect to the value of time incurred by employees of the Football Club in providing such support, nor was there a 5% uplift to costs incurred by the Football Club in providing the administrative support as permitted under the South Sydney Rabbitohs Co-Operation and Subscription Deed.

The Football Club administered all cash receipts and payments on behalf of the Company. Accordingly no independent cash flows have been

recorded by the Company for the current period.

The excess derived for the year ended 31 October 2017 of \$314,768 (2016: \$306,784) was granted to the Football Club in accordance with the terms of the restructure contained in the South Sydney Rabbitohs Co-Operation and Subscription Deed.

The excess for the year excludes share of profit/(loss) of associate as the South Sydney Rabbitohs Co-Operation and Subscription Deed notes that the amounts to be granted to the Football Club exclude amounts attributable to dividends received from the Football Club. The share of profits of associate would be realised through the declaration of dividends from the Football Club and thus should be excluded to ensure any future dividends will be beneficially received by the Company.

At the reporting date, an amount of \$518,127 (2016: \$294,764) is receivable from the Football Club with respect to 2018 subscription monies received on the Company's behalf.

#### SOUTH SYDNEY DISTRICT RUGBY LEAGUE FOOTBALL CLUB LIMITED

The Beginning...

South Sydney District Rugby League Football Club was formed at a public meeting held at Redfern Town Hall on 17 January 1908.

On March 5, 1908, the NSW Rugby League issued the Club its receipt No. 2 for their £ -1 - 1 - 0 affiliation fee.

The Club's first premiership match, also the first in the NSWRL competition, was played at Birchgrove Oval on Easter Monday, 20 April 1908. Souths defeated North Sydney 11-7. Winger Tommy Anderson scored Souths first try, with others added during the historic game by forwards Dick Green and Harold Butler, who also kicked a goal.

The Club was incorporated as a company limited by guarantee at a Special General Meeting on 13 June 1982.

The rebirth of the Rabbitohs began on 7 June, 2006 through a new partnership between Russell Crowe, Peter Holmes à Court and the 8000 Members of the Club. The voting Members of the Football Club voted by a 75.8% majority to convert the Club from a company limited by guarantee to a company limited by shares at an Extraordinary General Meeting held on 19 March 2006.

1925:	Won the first, reserve and third grade premierships and City Cup. First grade was undefeated in its 12 matches – the first and still the only team to
	win every game in a season.

**1953:** Won the first and reserve grade premierships, Club Championship and President's Cup (then the only interdistrict junior competition). Runner – up in third grade, losing 11-9, after playing extra time.

1968: Won first and reserve grade premierships, Club Championships, President's Cup and Flegg Trophy. Third grade defeated 14-9 in preliminary final.

1969: Minor premiers and runner's up in first grade. Minor premiers in reserve grade. Won third grade premiership, Club Championship, Pre-season Competition, President's Cup, Flegg Trophy and Ball Cup.
